SUBJECT: Changes to our Waste Management Services

In order to lower the risk of spreading the coronavirus in our waste processing centre in Tracadie, the APRSC will be implementing the following changes to its solid waste management services:

- **As of March 18, we will be ceasing all sorting operations. We will only be collecting regular waste, this being on a weekly basis. We therefore encourage you to store all of your recyclable items until our regular operations are back up and running.**
- **The waste processing centre will be closed to the public.**
- **The waste processing centre will be closed to individual clients as of Thursday, March 19.**
- **We will only be accepting waste from the municipal collection and from businessmen with multiple clients.**

The APRSC will continue to closely follow the evolution of the situation. These measures will be revised regularly and will be in effect until March 27.
